Suspensions - 2015-16

Sixteen male students and two female students were suspended for the following types of circumstances (nine of the students had student conduct history):

- Dating violence verbal (one student)
- Disruptive off-campus party while on University Probation (two students)
- Disruptive off-campus party and uncooperative/physical contact with police (one student)
- Driving under the influence while on University Probation (one student)
- Excessive use of alcohol underage and uncooperative with police while on University Probation (one student)
- Motor vehicle accident while driving under the influence of alcohol and a second alcohol related incident in the span of several days (one student)
- Motor vehicle accident while driving under the influence of alcohol while on University Probation (one student)
- Multiple thefts of University property and attempting to sell the stolen items (two students)
- Physical altercation while on University Probation (two students)

- Physical assault (one student)
- Physical assault and damage to property (one student)
- Physical assault and theft of prescription medication (one student)
- Possession of marijuana while on University Probation (one student)
- Possession and use of prescription medication not prescribed to the student, engagement in a set up to harm another student, and theft (one student)
- Threatening and disruptive behavior (one student)

Expulsions - 2015 - 2016

Twenty male students and two female students were expelled for the following types of circumstances (eleven of the students had a student conduct history):

- Disruptive, uncooperative and physical with staff (one student)
- Drug distribution (four students)
- Drug distribution and assault (one student)
- Drug distribution, use of marijuana and assault (one student)
- False reporting of an incident which caused a significant disruption (one student)
- Forging University documents and providing false information (one student)
- Harassment and disruptive behavior while on University Probation (one student)
- Harassment directed at sexual identity (one student)
- Intentionally contaminated the water of research animals (one student)
- Physical assault which was ethnically motivated (one student)
- Physical assault and assisting others in assault (one student)
- Physical assault and theft (one student)
- Sexual assault (three students)
- Stalking (two students)
- Stalking and dating violence (one student)
- Used a professor's identity to enter grading system and changed grades (one student)
